The selected person will work as a post-doc* in the research team of Professor Anna Śledzińska-Simon within the OPUS-21 grant (project number: 2021/41/B/HS5/01421).

Description of tasks:

- Analysis of the specificity of constitutionalism in Central and Eastern Europe and its impact on the situation of women as constitutional subjects, in particular: analysis and critical assessment of the implementation of women's rights in political processes, examination of the relationship between current standards of the rule of law and guarantees of women's rights, analysis of the constitutional interpretation of the concepts of dignity, autonomy and equality (gender equality), as well as the concepts of maternity, family and care in Central and Eastern European countries,
- Conducting study visits in 4 Central and Eastern European countries and compiling the collected research results;
- presentation of research results at scientific conferences;
- preparation and publication of articles in prominent international journals and book chapters based on the research results;
- active participation in the work of the research team;
- assistance in fulfilling administrative duties related to the project.

Requirements for candidates:**

- PhD in social sciences, preferably law, political science or sociology;
- proven interest in the area of constitutional law, comparative law and human rights;
- fluency in English to enable research and publications in this language;
- knowledge of one of the languages of Central and Eastern European countries;
- very good analytical and organizational skills
- availability and proven ability to work both individually and in teams.

* Post-doc position should be understood as a full-time position planned by a project manager for a person beginning his/her scientific career, who obtained his/her doctoral degree not earlier than 7 years before the year of employment in the project, including breaks and leaves.

** In accordance with the requirements of the National Science Center (further as NCN), a post-doc position may be filled by a person who a) will be selected in an open competition, conducted by a recruitment committee appointed by the head of the entity implementing the research project, consisting of the project manager as chairperson and at least two persons indicated by him/her, having appropriate scientific or professional qualifications. The evaluation of the candidates is based on the criteria specified in the announcement of the competition, and the results of the competition are made public by placing them on the website of the entity in which the research project will be implemented; b) the project manager was not a promoter or associate promoter of her/his dissertation; c) she/he has obtained a doctoral degree in an entity other than the entity in which the employment on this position is planned, or has had at least 10 months of continuous and documented postdoctoral training in an entity other than the entity implementing the project and in a country other than the country in which the doctoral degree was obtained; d) will be employed for a period not shorter than 6 months; e) during the period of obtaining this remuneration will not draw other remuneration from the funds allocated as direct costs from research projects financed within NCN competitions; f) during the period of obtaining this remuneration will not draw other remuneration from another employer based on an employment contract, including an employer based outside Poland.

Additional information concerning the conditions of participation in the call and the competition procedure

1. In the subject line of the application e-mail please write: **Competition for the post-doc position**
2. The application should include:
 - Curriculum Vitae;
 - Cover letter;
 - Information on academic achievements;
 - Electronic versions of two major publications (or typescripts of unpublished work) that the candidate considers representative of his/her scholarly achievements;
 - Two letters of recommendation sent directly to the chairperson of the Competition Committee at anna.sledzinska-simon@uwr.edu.pl.
3. The following statement should be included to the application: "I agree to the processing of my personal data for the purposes of organizing and conducting the competition and providing information about the results of the competition. I acknowledge that the administrator of the personal data is the University of Wrocław, Plac Uniwersytecki 1, 50-137 Wrocław. I am aware that providing the data is voluntary, but necessary for the purposes for which they were collected (in accordance with the Act of 10 May 2018 on the protection of personal data, Journal of Laws of 2018, item 1000)".
4. Evaluation of applications of candidates will be carried out by the Competition Committee in accordance with the Regulations for the allocation of funds for the implementation of tasks financed by the National Science Centre in the field of research projects, post-doctoral traineeships and PhD scholarships. The committee reserves the right not to grant the scholarship and to renew the competition if the candidates fail to meet the requirements set out in the competition or other important circumstances appear which influence the planned project implementation.
5. The Commission will evaluate the applications on a point scale. The employment contract will be offered to the person with the highest number of points.
6. In case of resignation of a candidate with the highest score, the Commission reserves the right to select the next candidate from the ranking list.
7. The Commission will contact only selected candidates by March 20, 2022.

Information clause for persons participating in the recruitment process:
