How to pass the course?

- During classes will be many activities from which you will be able to get a grade (e.g. questions, discussions, homework) 20% of final grade.

How to pass the course?

 - Terrorism in scope of International Humanitarian Law (presentation date: 2024-03-27).
 - Relevance of international human rights law for International Humanitarian Law (presentation date: 2024-04-03).
- Each presentation should contain references to international humanitarian law acts or scholars' papers, examples, court judgments, etc.
- Within the scope of the presentation you're preparing, you can organize a test that the remaining students will later solve. The results of this test can be included in the grades for activity.

How to pass the course?

- Now divide yourself into three groups and share your future work with each other.
- You must learn to work together in a group, share work and set goals.
- Please send me your final presentations one day before the scheduled presentation date so I can review them and give a grade

How to prepare a good presentation in a group?

- Divide Work: Divide the task into smaller parts and assign each group member a specific responsibility. This can include roles such as a lead researcher, designer, presenter, and editor.
- Research: Ensure each member contributes to the group's research efforts by finding relevant information in library resources or on the Internet. Encourage collaboration in gathering diverse sources and perspectives
- Prepare Presentation: Divide the design of the presentation among the group members using tools like Keynote or PowerPoint. Assign each member specific slides or sections to work on.
- Rehearse: Schedule a rehearsal where group members can practice presenting their assigned slides. This will ensure a seamless presentation and give members a chance to familiarize themselves with the content

How to prepare a good presentation in a group?

- Peer Review: Encourage members to review and provide feedback on each other's work. This will help improve the overall quality of the presentation and encourage a collaborative environment
- Final Touches: Prioritize tasks such as creating a cohesive narrative, adding visuals, and ensuring the presentation is visually appealing and engaging.
- Teamwork: Emphasize the importance of effective communication, coordination, and teamwork throughout the process. Encourage members to support each other and resolve conflicts constructively

The topic of the next class

- Next classes will be dedicated to the origin and historical development of international humanitarian law.
- International humanitarian law, also known as the laws of war or law of armed conflict, is the branch of international law that regulates the conduct of armed conflict and seeks to protect people who are not or no longer participating in the hostilities (warfare).
- The modern development of international humanitarian law began in the 19th century with the establishment of the Red Cross and the adoption of the first Geneva Convention in 1864, which aimed to improve the treatment of wounded soldiers during armed conflicts.
- Since then, international humanitarian law has evolved through the adoption of additional treaties, including the Hague Conventions and the four Geneva Conventions, as well as through the establishment of institutions such as the International Committee of the Red Cross (ICRC) and the International Criminal Court (ICC).
- And we will discuss this topic in detail in our next class.
