Freedom

freedom of choice within the limits of the designated law

The role of the state is: a) creating a system of guarantees securing the enjoyment of freedom, b) refraining from interference.



legal right: entitlement of an individual with which the legal obligation to perform certain behavior of another entity (state) is correlated



Subject of constitutional freedoms and rights

- I. Human being as a natural subject of freedoms and rights
 - conditions for diversifying the scope of rights and freedoms in the light of the Constitution of the Republic of Poland (citizenship, age, sex, other)
- II. Legal persons as recipients of constitutional rights and freedoms



Sources of international human rights law

- international conventions (general or particular)
- international custom, as evidence of general practice accepted as law
- general principles of law recognised by civilised nations
- subsidiary means for the determination of rules of law

Regional conventions – League of Arab States

• Arab Charter on Human Rights [2004]

On Jan 24, 2008, the High Commissioner for Human Rights, Louise Arbour, has stressed that the Charter is incompatible with international standards for women's, children's and noncitizens' rights, and in that it continues to equate Zionism with racism.

International custom

- general practice accepted as law
- usus: practice supported by broad consensus in terms of content and applicability
- opinio iuris sive necessitatis: belief that this practice is binding law



International custom

 General Comment 24 [1994] of the Human Rights Committee:

State may not reserve the right to engage in slavery, to torture, to subject persons to cruel, inhuman or degrading treatment or punishment, to arbitrarily deprive persons of their lives, to arbitrarily arrest and detain persons, to deny freedom of thought, conscience and religion, to presume a person guilty unless he proves his innocence, to execute pregnant women and children, to permit the advocacy of national, racial or religious hatred, to deny to persons of marriageable age the right to marry, or to deny to minorities the right to enjoy their own culture, profess their own religion, or use their own language. And [...] the right to a fair trial [...].



General principles of law – examples

- principle of proportionality
- principles of fairness and justice
- lex retro non agit
- good faith
- res iudicata
- impartiality of judges
- prohibition of abuse of rights



Subsidiary means for the determination of rules of law

 judicial decisions and the teachings of the most qualified publicists [Article 38 of the Statute of the International Court of Justice]
